Fees relating to Foreign Currency Transactions	(a) Transactions in currencies other than Hong Kong Dollars incurred outside of Hong Kong or in Hong Kong: Transactions effected in currencies other than Hong Kong dollars which are converted into Hong Kong dollars on the date when the transaction is processed by the Company at an exchange rate determined by VISA/MasterCard shall be debited to your account plus a handling fee of 1.95% of that amount (inclusive of the reimbursement charge levied by VISA/MasterCard on the Company at the rate of 1%). (b) Transactions in Hong Kong Dollars incurred outside of Hong Kong: MasterCard transactions in Hong Kong dollars incurred outside of Hong Kong will be imposed a reimbursement charge of 0.95% (inclusive of the reimbursement charge levied by MasterCard at the rate of 0.8%) which shall be debited to your account.

Remarks

- (a) This Fees Schedule is applicable to VISA/MasterCard credit card including personal credit card, commercial credit card, all Affinity/Co-branded Cards and Virtual Cards. It is also applicable to Private Label Card save and except clauses 2, 3, 4, 11, 15 and 17. The Company reserves the right to vary the fees and charges from time to time by notice to customers. The fees and charges for other card products and/or services may be separately published.
- (b) Any withdrawal or fund transfer of the credit balance or any part thereof from the credit card account by the cardholder, except effected by way of a refund procedure prescribed by the Company from time to time, will be treated as a cash advance transaction.
- (c) If Spending Tier Rate is applicable to the cardholder's credit card account, the annual interest rate may be lower than that described herein. Please refer to the "Leaflet on Personalized Interest Rate" included in the welcome package or the Company's letter to the cardholder on Personalized Interest Rate.
- (d) The Company may in accordance with the provisions for Overdue Interest Rate charge an annual rate in addition to the basic interest rate applicable to the outstanding balance in the cardholder's credit card account if no payment or payment of less than the Minimum Payment is made on or before the relevant Due Date for such number of times within such period as the Company may from time to time determine and notify the cardholder. Please refer to the "Leaflet on Personalized Interest Rate" included in the welcome package or the Company's letter on Personalized Interest Rate or its letter on Overdue Interest Rate to the cardholder.
- (e) This Annualized Percentage Rate (APR) is computed in accordance with directions given by the Hong Kong Monetary Authority.
- (f) This rate applies to all cash advance, cash before card and payment or fund transfer through "JET Payment" transactions.
- (g) If the credit balance arises from any tax refund, the charge will be 2% of the tax refund (subject to a minimum of HK\$50).
- (h) Chargeable upon the initial issuance and each renewal or re-issuance of a MasterCard SideCard.
- (i) If the current balance exceeds the credit limit of the Card, an overlimit handling fee will be debited to the account.
- (j) For card payment made by CHATS, service charges may be levied by the paying bank and the beneficiary banks. Please contact the relevant banks for the details of service charges.
