<u>Terms & Conditions of "Up to 15X Rewards Gift Points on Online Spending for BOC Credit</u> <u>Cardholders":</u>

- "Up to 15X Rewards Gift Points on Online Spending for BOC Credit Cardholders" (the "Promotion") commences from 1 September to 31 October 2017 (both dates inclusive) (the "Promotion Period"). The registration period commences from 10:00 on 1 September to 23:59 on 2 November 2017 (the "Registration Period"). - 2.
